

# PROGRAMME LEAD 2024

(Leadership for Environment, Awareness and Development)

15 - 30 May, 2024



The Education for Youth Empowerment (EYE) Area of Environment Education and Awareness (EEA) Division at The Energy and Resources Institute (TERI) has designed a summer programme that enables school students to gain knowledge, enhance their skillsets and obtain access to resources and networks to strengthen their competencies on issues related to environment and sustainable development. Technical sessions by subject experts, hands-on training, internship opportunity and mentoring on sustainability linked topics are some of the key activities curated within this holistic programme. The proposed programme will cover various domains of sustainable development with regard to research, science, technology, community engagement and outreach. The intended outcomes of the programme are to nurture a cadre of environmentally conscious students who will spearhead changes at various levels (individual, peer, family and community) while concurrently accentuate skill sets and civic life, strengthening their portfolios for targeting further education opportunities.

Building on the success of the preliminary program held in Delhi in 2023, we have refined and enhanced the programme. We look forward to implementing the improvements and delivering a more valuable experience for the participants.

## Programme guidelines:

1. Programme LEAD is open to students of the age group 12-18 years and will be carried out from **15<sup>th</sup> May to 30<sup>th</sup> May 2024**.
2. The medium of instruction is **English**.
3. Programme LEAD is designed to introduce students to the Environment and Sustainability sector and is structured to cover the following:
  - a. Organizational Study
  - b. Orientation to work culture and ethics
  - c. Foundational Course to Environment and Sustainability
  - d. Core Thematic Areas:
    - i. Biodiversity Conservation
    - ii. Climate Change
    - iii. Circular Economy and Waste Management
    - iv. Water Sanitation and Hygiene
    - v. Green buildings
    - vi. Mission LiFE
    - vii. Renewable Energy, Biofuels and Just Transition
  - e. 21<sup>st</sup> century skill sets
  - f. Project Management
  - g. Documentation and Communication
  - h. Presentation and Evaluation
4. Students are expected to come to TERI office at Bangalore on all days. Travel cost will be borne by the students.
5. The programme duration is from 15<sup>th</sup> May to 30<sup>th</sup> May 2024; - 5 days a week. Public holidays if any observed by the TERI Bangalore office will be applicable.
6. The total number of hours the student must dedicate to the programme is 60. The program will roughly adopt a 60:40 ratio for online and in-person presence at the TERI office.
7. The programme agenda and a roster for the applicant's presence at the TERI office will be maintained. It will be the responsibility of the student to be in office at the prescribed time.
8. One self-photograph and signed consent form from the parent/guardian need to be shared by the applicant at the start of the programme.
9. Each student will be assigned to TERI professionals who will supervise and mentor them.
10. Students will need to follow the office decorum. Zero tolerance policy applies for misbehavior.
11. Adherence to timelines especially for tasks/assignments is requested to ensure that the entire course is completed within the stipulated time.
12. On completion, students will be felicitated with certificates and will be provided access to an e-Docket containing resource materials.
13. Programme participants get an opportunity to be part of the TERI Youth Alumni and network and stay connected with TERI's future initiatives.
14. The student will be provided with vegetarian refreshments and snacks on the first and last day of the programme.

15. The programme fee of Rs.4500/- per student (including GST) is to be submitted at the time of registration. This fee covers the programme cost, resource materials and refreshments.
